Photoshop Elements is a free version of Photoshop. With only limited editing capabilities, Photoshop Elements is a good option for beginners. Zoom Adobe Photoshop has the capability to zoom into an image to view the detail of an object in the image. It can be used to magnify or reduce an image by moving the zoom window around the image or by zooming

in or out by using the zoom tool that can be found in the Tools panel. Photoshop also has the ability to rotate the image left, right, up, or down. The Zoom tool in Photoshop has a single setting that can be toggled with the eyedropper tool (explained next) or by choosing Camera \rightarrow Zoom (Live View) from the Tools panel or Window → Zoom. Figure 2-1 shows a closeup of a butterfly with the Zoom tool active. You can see that the

butterfly appears to be a few inches from the real position of the butterfly in the photo. The difference in size is the magnification of the Zoom tool. You can achieve the same effect in Photoshop Elements by selecting Image \rightarrow Zoom \rightarrow Zoom in (in the menu at the bottom left of the Image window) or by choosing View \rightarrow Zoom In. To increase the size of the image, also known as _zoom out_ (see Book III,

Chapter 5), just press the Ctrl (Windows) or \mathbb{H} (Mac OS) key and the + key on your keyboard simultaneously. **Figure 2-1:** The Zoom tool, which is found in Photoshop, enables you to zoom in or out on an image. Cropping an image Cropping is the process of selecting a specific portion of an image and removing all or part of the image outside the chosen area. Cropping is a useful tool for organizing your image collection

and making it easier to see or work with the specific image that you want to keep. When you crop an image, its borders become transparent, and the _crop mark_ (the area that you've cropped) remains transparent. If you need more of an image, just drag the crop mark around. If you need less, just remove the crop mark by dragging it outside the image. Photoshop's crop tool enables you to select a rectangular or

elliptical border of an image and remove all the pixels inside it. It's a fairly simple tool, as shown in Figure 2-2. **Figure 2-2:**
