Sec. 2254. The issue on appeal is whether the record before the Ohio court that heard petitioner's post-conviction appeal shows that petitioner had cause for failure to perfect his appeal on the basis of the denial of his request for trial transcripts. We affirm the judgment of the District Court. I. 6 On November 9, 1977, petitioner was convicted of the robbery and rape of a woman who was shot and killed during the attack. He was sentenced to death on October 10, 1978. On October 31, 1978, petitioner's court-appointed appellate counsel filed a brief in the Ohio Court of Appeals raising three assignments of error.
