Home Finance Corporation is the holder of a "revolving loan," which by its terms, requires monthly payments of principal and interest. In a previous case, the debtor filed for a Chapter 7 discharge and listed the plaintiff as a creditor to be paid as an unsecured creditor. The plaintiff herein did not file a proof of claim, but instead sought to determine dischargeability of the debt under 11 U.S.C. § 523(a)(2). The debtor, Mr. Currie, filed his answer on April 30, 1985. He did not plead the statute of limitations as a defense to the action but he did *308 move for summary judgment on the ground that the plaintiff had not filed a timely proof of claim. On May 7, 1985, the plaintiff filed a motion requesting that its complaint be amended to include a prayer for a judgment of nondischargeability of the debt. The defendant filed a memorandum in opposition to the motion. On June 14, 1985, the plaintiff filed a "written withdrawal" of its motion to amend the complaint.
