The jury could only speculate about the question of defendant's knowledge or lack of knowledge. Plaintiff did not present any evidence that the condition had been known or should have been known to defendant. Hence, the first element of the plaintiff's case fails. [5] Assuming arguendo that defendant knew or should have known of the dangerous condition, plaintiff still has not presented any evidence that defendant had the time to correct the dangerous condition. The only evidence plaintiff could produce to show that the condition had existed for a sufficient amount of time to give defendant a reasonable opportunity to correct it was that the ice had existed for about one week. However, there was no evidence that defendant had any opportunity to correct the condition during the brief time period it existed. Plaintiff's evidence only indicates that defendant may have come out onto the deck a few days after the ice had formed. Plaintiff did not introduce any evidence that defendant was aware of
