The district court will determine the factual basis for the defendant's restitution order in light of these principles. We will defer to the district court's factual determinations unless they are clearly erroneous. The district court has broad discretion in deciding whether to order restitution and the scope of restitution allowed. United States v. Coon, 974 F.2d 1234, 1237-39 (10th Cir. 1992). A district court's decision to impose restitution will be upheld as long as it is based on "at least a minimal factual foundation," United States v. Manzer, 69 F.3d 222, 230 (8th Cir. 1995). -11- In order for a defendant to be liable for restitution, the government must show a sufficient relationship between the victim's loss and the conduct of the defendant. Hughey v. United States, 495 U.S. 411, 413 (1990); United States v. Angiulo, 847 F.2d 956, 985 (1st Cir. 1988). The government has "the burden of proving the amount of loss suffered by a victim" in a § 3663A case. 18 U.S.C. § 3664(e). In reviewing an order of restitution, we look to the "scope of the ruling and the reliability of the evidence" to see if the order is "fairly supported by the record," and to see if the court has "giv[en] an adequate statement of reasons for the amount." Hare, 873 F.2d at 703, 704. Although our review is deferential, we may not uphold a restitution order against a challenge to a specific fact that was found
