The General Partner of the Partnership Interest has the sole option to purchase all or any of the Partnership Interest of the Other Investors at any time at a price equal to the Average Closing Price. If the General Partner does not exercise its right to purchase, it shall sell the Partnership Interest to all or any one of the Investors if. the total market value of all the Partnership Interests is. superior to the. Average Closing Price is defined as the arithmetic mean of the average closing price for such Common Units on the date of the notice of purchase, or if no closing price was publicly announced, the next highest. price per Common Unit on a trading date, as listed on the NASDAQ floor, or, if no price was publicly announced, as listed on the Financial Industry Regulatory Authority. (3) The Partnership shall give written notice to the Other Partners no later than 45 days before the Initial Purchase Notice of an intention to purchase a Partnership Interest. The General Partner may have a reasonable time period in which to require notification of All Other Partners of the Partnership Interest being offered for sale, or of its intention to purchase a Partnership Interest. A period of up to 45 days may be allowed by agreement of the Partners or by appropriate Bylaws. Any Partner has the right at any time, but not less than seven days before the Initial Purchase Notice or any renewal of the Initial Purchase Notice, to notify the General Partner that the Offer to Purchase a Partnership Interest made by the General Partner constitutes an unfair or inequitable practice. Within such time, the Investor may object by written notice to the General Partner. Within five business days of receipt of the Investors' objection, the General Partner shall have an opportunity to respond to the objections. Failure to dispute the validity of the objection within the five-day period will constitute a rejection of the objection. The General Partner may offer terms of sale to such Investors that are different than the offer terms to the Other Partners. The General Partner shall not make any agreement for the sale of a Partnership Interest that is different than the offer terms to the Other Partners. The General Partner shall pay the Investor the purchase price per Common Unit for the Partnership Interest within 10 days of the notice of purchase. The Purchase Price shall be equal to 100% of the average Closing Price for Common Units of the Partnership Interest on the date of the notice of purchase, or if no closing price was publicly announced, the next highest closing price for Common Units for the period during which the Investors had rights to purchase the Partnership Interest.

I know that the above pdf file contains some kind of information that I can't access. Can someone please help me out with this? I can't seem to find any other way to download this file. A: The DirectShow extender filter you are trying to get the video (WMV) from seems to be locked to a special driver with Windows Media Player, and you can't download that driver when you install your extender filter. The NetShow filter that I use has no such driver, and that's the only driver I know of that can download WMV videos. The bottom line is that your extender filter can't successfully grab a file that it knows nothing about. You may be able to change the net show filter's download source to your screen capture software, and then capture the output from the software. The authors present the results of examinations performed on 1,554 randomly selected cigarette smokers to search for a possible relationship between cigarette smoking and non-neoplastic diseases of the respiratory tract. The smokers examined were divided into 4 groups according to the amount of tobacco they smoked per day: group I: more than 20 cigarettes per day; group II: 10-19 cigarettes per day; group III: 5-9 cigarettes per day, and group IV: less than or equal to 4 cigarettes per day. The following non-neoplastic diseases of the respiratory tract were considered: bronchitis, asbestosis, silicosis, chronic bronchitis and emphysema. The incidence of tuberculosis in the examinees was minimal and for that reason not taken into consideration. The incidence of bronchitis, asbestosis and chronic bronchitis as well as the total incidence of non-neoplastic diseases of the respiratory tract did not differ from those in the control group. However, the incidence of silicosis was higher in the group that smoked more than 20 cigarettes per day than in the control group (p less than 0.001).
