A: Its no fixed size for click and on call to it to run. So the order doesn't matter. The present invention relates to a bucket or scoop for melting ice and snow from an open area and pouring it into a receptacle. A prior art scoop for melting and pouring ice and snow is shown in U.S. Pat. No. 5,049,401. The scoop is not complete, having an open top with a pouring spout and a bottom that is open into a receiving cavity, and does not protect the receiving cavity from entry of liquid from the open top. The scoop shown in U.S. Pat. No. 3,696,949 is an open bucket having a closing lid over a receiving cavity and does not have a pouring spout and does not have a bottom open into the receiving cavity. This scoop is no better than the scoop of U.S. Pat. No. 5,049,401. It is desirable that the scoop for melting snow and ice have the ability to melt snow, ice or ice and snow within an open area while preventing the liquid from overflowing the edge of the scoop and hitting anyone in the area. It is also desirable that the scoop be closed after melting when ready to pour and keep its contents from dropping out when not in use. In the fall of 2006, the federal government made a bold move to revolutionize the way we teach our children at the elementary school level.
